UIP Process Trainings

Full-day UIP sessions will be offered in two locations within the state, sponsored by CDE in partnership with the Center for Transforming Learning and Teaching (CTLT). These sessions address each step in the Unified Improvement Planning (UIP) process, and are designed for school or district-level planning teams. Each session will be held from 8:30 am to 4 pm (lunch provided). Participants should consider bringing a small team of stakeholders that need to become more familiar with UIP processes and expectations, such as English Language Directors, Special Education Directors, Assessment Directors, principals, teacher leaders, etc.

Progress Monitoring: This session will focus on implementing unified improvement plans through a continuous improvement process. Participants will build a plan for using data from interim measures throughout the school year to determine if action steps are having the desired effects on student learning. They will use data from implementation benchmarks to evaluate the degree to which major improvement strategies are being implemented, and make adjustments as needed. This session will also address how to engage various stakeholders, including school and district accountability committee members, in progress monitoring. Participants will leave with processes, protocols and tools for engaging with local planning teams to monitor the progress of school and district improvement efforts. Participants should bring a current draft of their 2012-13 Unified Improvement Plan to the session.
