School and District Performance Frameworks - Available Now

Preliminary 2023 District and School Performance Frameworks are now available in Syncplicity for districts.

The reports and corresponding data are available to <u>district accountability contacts</u> via Syncplicity and are located in the 'Prelim_2023_Frameworks' subfolder that is located within your district's 'Accountability_Contact' folder (File path: 'Performance Framework' -> 'Prelim_2023_Frameworks'->'2023_Preliminary_Reports'). CDE will be releasing preliminary framework ratings to the public on **August 29** at this location:

http://www.cde.state.co.us/accountability/performanceframeworkresults. CDE will provide a press release. The tentative schedule to publish finalized framework ratings publicly is:

- November 2023 (after the state board meeting) for districts and schools not participating in request to reconsider
- December 2023 (after the state board meeting) for districts and schools participating in request to reconsider

In the meantime, on or after August 29 you may choose to share the preliminary results publicly with the media or others. We do ask that you keep the results internal to your schools/district until August 29 to honor the time other districts may need to respond to media inquiries.

Accreditation and Request to Reconsider - Action Required by September 22

Required for All Districts, regardless of participation in request to reconsider

Accreditation. To officially sign off on school plan types and the district's accreditation rating, the district must review and verify the district rating and school plan types using the Accreditation Form (in the Accreditation Portal within the ACI/UIP online system, available now to district accountability contacts). For Accountability Contacts to access the Accreditation Portal, your district's Local Access Manager (LAM) will need to modify the login role to "Accountability Contact", as described in this guide. For additional support, fill out the assistance request form using your district's information. The form must be submitted by **September 22**.

Request to Reconsider. Request to reconsider is the district's opportunity to request reconsideration of a school or district's preliminary rating based on additional evidence. To initiate the process, eligible schools and districts must complete the Accreditation Form (described above). Once submitted, this will trigger the Accreditation Changes tab(s), where evidence can be submitted. All evidence must be submitted by **October 16** and must be aligned to the criteria outlined in <u>guidance</u>. All districts have the opportunity to rescind requests prior to the deadline. The department will reach out if the district or one of your schools meet the participation and threshold expectations for certain conditions (e.g., districts with a single school, impact of Alternative Education Campuses on the District Performance Framework). Schools and districts eligible for these conditions do not need to submit additional materials for review.

Technical Assistance and Support. Guidance and tools for the accreditation and request to reconsider process is available on the <u>CDE website</u>. Federal Identification

By the middle of September, districts will receive information about ESSA federal identifications for schools and the resources available for support. For more information about ESSA school identifications, go to http://www.cde.state.co.us/fedprograms/essa csi tsi.

Unified Improvement Plan

The 2023-24 online Unified Improvement Plan (UIP) system is already available for school and district use. The prepopulated report (section 1) will be updated with the preliminary performance framework data and other relevant program information (i.e., state and federal requirements) over the next couple of weeks. Districts and schools are required to submit their Unified Improvement Plan by October 16. Newly identified schools and schools participating in request to reconsider may request an extension. District Admins/Users or Accountability Contacts must denote if eligible schools/the district will be using the extension on the UIP Details page, see the guidance for additional detail.

Biennial Flexibility. The biennial flexibility is available to districts and schools that earn a Performance plan type (or higher) to submit their plans for public posting every other year. Eligibility for this flexibility is available on the <u>UIP</u> <u>website</u> as of August 29. Note that Insufficient State Data ratings are not eligible for this flexibility.



Parent Notification and Public Hearing – Action Needed within 30 Days. For any districts with schools that received Priority Improvement or Turnaround plan type, this is a reminder that the parent notification and public hearing process has a fairly tight timeline. Parents must be notified within 30 days of receiving the plan type; the public hearing must be scheduled no sooner than 30 days after notification. This is to help ensure families are getting the information, but also to inform technical assistance opportunities. Regional Support Visits

Statewide Performance Framework Trends

Included in this section is a summary of statewide trends on the 2023 frameworks. Overall, the news is positive, however there are some areas for the state to monitor.

- Increased percentage of districts and schools at higher ratings
 - O There was a greater percentage of districts and schools earning Accredited/Performance and Improvement plan types in comparison to 2022. For example, 78% of schools earned a Performance or Improvement plan type in 2023 compared to 71 % in 2022 before request to reconsider. Likewise 71% of districts earned an Improvement or higher rating compared to 2022 with 54% of districts.
- More districts and schools have enough data to calculate plan types
 - O As the state continues to recover from the pandemic, we saw a healthy *decrease* in the Insufficient State Data (ISD) category. As expected with access to two years of data, more small systems had enough data to receive a plan type. The number of districts and schools with an ISD assignment is still higher than it was pre-pandemic, however. We will keep an eye on this, but another decrease is expected in ISD assignments next year when we can aggregate three years of data for smaller systems.
- Decreased number of sites on Accountability Clock
 - Overall, there was a decrease in the number of sites on Performance Watch (e.g., on the accountability clock) since 2022. This claim still holds true when considering the number of sites that participated in request to reconsider to exit the clock in 2022 (i.e., request to reconsider was the only path for schools to exit the clock in 2022). Unfortunately, there was an increase in the number of sites with Priority Improvement assignments, with a much greater concentration in newly identified sites. Because these sites are so new to being on the accountability clock, the department will be offering a blitz of services. Historically, about 60% of districts and schools on Year 1 on the clock have been able to exit within a year.
- Participation Issues are Impacting Plan Type Assignments
 - O We are still noting a high occurrence of plan types being lowered because of state assessment participation issues – referred to as "Decreased due to Participation." The number of sites falling into this category has decreased from last year but not by as much as we were expecting. Last year, the prior Commissioner waived the requirement to provide another year of grace as sites experienced some coding issues, especially at the high school level. The department provided more guidance and training



on the Student Biographical Data (SBD) process over the past year. This year the requirement is being applied to the framework calculations. The department will continue to support the field to avoid this penalty in the future.

As a reminder, the performance framework assignments are preliminary. Districts have the opportunity to review their preliminary reports and determine whether to participate in the <u>request to reconsider process</u>. The number of higher plan types will likely increase by the time plan types are finalized in December. Also of note, frameworks for Alternative Education Campuses (AECs) are being calculated now and will be released in September. As of August, there are 94 schools with approved AEC status. These schools are not yet included in the school summary tables below.
