Organization name: STRIVE Prep

Summary
<p>STRIVE Preparatory Schools (“STRIVE Prep”) is a charter management organization that currently serves 3,600 students in 11 schools at the elementary, middle and high school levels with 91% of students qualifying for free or reduced lunch and 97% identifying as students of color. All of STRIVE Prep’s schools are currently in Denver. Strive Prep has a track record of success including 8 of 11 schools being blue or green on the Denver School Performance Frameworks. STRIVE Prep’s application indicates they are willing to work in the Denver metro area and “other regions if conditions are appropriate.” The application provides clear information regarding their educational model, strategies for community engagement and processes for opening up new schools and partnering productively with school districts.</p>

Yes	STRIVE Prep clearly describes their mission and educational model. STRIVE Prep was founded more than ten years ago “on the belief that every students should have access to a high quality education right in their neighborhood.” STRIVE Prep’s student body of approximately 3,600 students consists of 91% of students qualifying for free or reduced lunch, 97% of students identifying as students of color, 49% are English language learners and 14% are on an Individualized Education Program.

It acknowledges that every community is unique and that STRIVE Prep would need to be intentional and responsive to each communities' needs.</p>

STRIVE Prep would need explicit agreements around transportation, enrollment, facilities, purchased services, special education services, waivers, phase in/out of grades to be served, administrative fees and equitable revenue sharing.</p>

STRIVE Prep is intentional about soliciting feedback from the community and holding "listening sessions to better understand community needs." STRIVE Prep further details steps the leader will take to ensure regular communication with the community and the plan also explains their comprehensive family engagement program called STRIVE Together.</p> <p>Before committing, STRIVE Prep would work to understand revenue available and once available, prepare a budget. STRIVE Prep indicated it "would likely fundraise for the higher costs associated with school turnaround" and that "past fundraising efforts have proven</p>

		successful.” All of the sub-questions are addressed concisely and thoroughly in the application.
