## How do I get a WIDA Secure Portal account?

ELD Program and/or District Assessment Coordinators (DACs) will create a bulk upload with educators' names and email addresses. Once the bulk educator list is created, a user with District permissions will upload this list to WIDA Client Services Center (CSC). After WIDA CSC receives and processes the bulk upload, an automatic email will be sent to educators on the list inviting them to create an account through the WIDA Secure Portal. This account will give access to self-paced workshops and other workshop resources.

## What is the deadline to send the bulk upload list to WIDA CSC?

This is a district decision. Teachers can access WIDA Self-Paced Workshops once the bulk upload list is sent and processed.

## Should districts send the names of all staff members or just individuals who wish to participate?

This is a district decision. If someone receives an invitation from WIDA to create an account, they do not have to accept the invitation to participate.

## Are virtual WIDA Workshops required?

No, participation is optional. Workshop participation will, however, help satisfy some hours related to the 45 hour English Learner Professional Development requirement for licensure renewal.

## Is there a cost to participate in these Workshops?

No, there is no cost to K-12 public school educators.

# Does the invitation to create an account expire after a certain amount of time?

The invitation to create an account does not expire – as long as the educator has access to the email provided in the bulk upload list.

## What if I already have a WIDA Secure Portal account?

Those who already have an assessment related account in WIDA.wisc.edu will receive an email that eLearning permission has been added to their account. An invitation to sign into the Secure Portal will be sent once the district uploads and WIDA CSC processes the bulk educator list. If the former test administration account is inactivated within three years, the account will be re-instated with the eLearning permission added. If the former test administrator account has not been logged into for more than three years, the account and history will have been removed; anticipate receiving an invitation to create a new account.

## I started working in my district later in the school year. How do I get a WIDA Secure Portal account?

Contact your District Assessment Coordinator (DAC) to request an account activation on your behalf. WIDA will email you and invite you to create an account through the WIDA Secure Portal. This account will give you access to self-paced workshops and other workshop resources.

## I am not currently working in a district, but I want hours to maintain my license. Can I access these virtual Workshops?

No, WIDA Self-Paced Workshops are currently only available to Colorado K-12 public school educators with a district email address.

## Is there a limit to online Workshop enrollment?

No, enrollment is unlimited for WIDA self-paced workshops.

## Who can participate?

K-12 public school educators currently working in a Colorado school district can access and participate in the WIDA Workshops.

### When should I complete Workshops?

New courses are offered each school year. Educators must complete SY24-25 workshops by August 31, 2025.

## Will I get a certificate after completing a virtual Workshop?

After educators complete a self-paced Workshop, they can print and/or download and save their Certificate of Completion. CDE encourages participants to download and/or forward certificates to their personal email as WIDA or CDE will not be able to reproduce certificates or confirm participation.

## Will these Workshops count towards the new English Learner PD Requirement for relicensing?

Yes, the Workshops listed in this document are aligned to the English Learner Professional Development Quality Standards, and the certificates you print after completing the eWorkshops can be submitted to CDE Licensing with your completed EL Professional Learning Standards Matrix and renewal application.
