Robert Hammond came to the Colorado Department of

Education in 2008 as Deputy Commissioner of

Administration and Operations; and,

WHEREAS:

He was noted for his effective, consistent, visionary and

supportive leadership and thus he was given increasing

responsibilities at the Department; and,

WHEREAS:

Mr. Hammond was appointed as the interim commissioner

in December 2010 while the Colorado State Board of Education conducted a national search for a new

Commissioner of Education; and,

WHEREAS:

The Colorado State Board of Education requested that he

submit his name for consideration for the position of

Commissioner of Education; and,

WHEREAS:

The Colorado State Board of Education unanimously

selected Robert K. Hammond as the Commissioner of

Education in May 2011; and,

WHEREAS:

The Commissioner was charged with implementing several

major education improvement programs throughout the state based on laws passed by the Colorado Legislature, signed by the Governor and as appropriate, detailed in

Colorado State Board of Education rules; and,

WHEREAS:

The Commissioner recruited and retained one of the nation's strongest leadership teams to lead the agency through the process of developing the new education initiatives in collaboration with school districts across the

state and other stakeholders; and,

WHEREAS:

The Commissioner has been deeply committed to providing

districts the most useful supports and services from all

offices at CDE, he has transitioned the department from one that focused primarily on compliance to one of service and support thus prompting many superintendents to respond to the Commissioner's annual evaluation survey with words of high praise and appreciation; and,

WHEREAS:

Through his focus on serving the state's 178 districts, the department was able to effectively implement new academic standards, new assessments, a new educator evaluation system, a new accountability system and a new early literacy law in accordance with the timelines and requirements outlined in state law; and,

WHEREAS:

The Commissioner's dedication to fiscal accountability improved the department's practices and brought trust and respect from the U.S. Department of Education regarding the department's federal compliance; and,

WHEREAS:

The department became highly regarded for its expertise, support and service to schools and districts across the state; and,

WHEREAS:

A collaborative and supportive relationship was established with a broad group of stakeholders throughout the state including businesses, foundations and non-profit organizations; and,

WHEREAS:

Education leaders across the state praised the Commissioner for his leadership, accessibility and courage to seek out diverse opinions in order to make the best decisions for students and communities; and,

WHEREAS:

State legislators gave public recognition to the Commissioner for his strength of leadership, credibility and high ethical standards in making sound policy recommendations to lawmakers; and,

WHEREAS:

His service on various commissions, boards and executive leadership groups, among them the PARCC governing board, the Council of Chief State School Officers and Colorado Creative Industries Council, was a tribute to his peers' recognition of his quality leadership, ethical standards, problem-solving abilities, collaborative skills and credibility across leadership groups around the nation;
