Dear Superintendents and BOCES Directors,

I hope you are well and that you have been able to enjoy the gorgeous fall we're having this year. I have been learning a lot during my visits to Colorado schools, and I am so grateful for the leadership you provide in your districts, BOCES and communities. I am reaching out today to share information about rulemaking before the State Board of Education and to make sure you are aware of a procurement for our CMAS and CoAlt assessments. In addition, I want to encourage you to nominate an individual from your district to participate in the proposal evaluation process.

Rulemaking activities by the State Board of Education

I've heard from a few of you that you are not always aware of the rulemaking proceedings before the State Board of Education. Our State Board of Education Office sends out notices of rulemaking as part of the board's regular meeting notices, so be sure to check those if you're interested in following rulemaking proceedings. The board office also sends out an announcement when rules are approved. These emails come to you from Angela Maramba, director of State Board Relations. At the state board's meeting in November, we will hold hearings on the following rules:

- Rules for the Administration of the Adult Education and Literacy Grant Program, 1 CCR 301-98
- Rules For the Administration of the Healthy Meals for All Program, 1 CCR 301-114
- Rules for the Administration of the Exceptional Children's Educational Act (ECEA) 1 CCR 301-8

CMAS and CoAlt Request for Proposals

CDE released a Request for Proposals for a new CMAS (all content areas) and CoAlt (science and social studies) contract last week. This procurement is required because the current contract for these assessments will expire this summer, and the first administration under the new contract is expected to begin in spring 2025. Unless changes in the assessment content and design are required by future legislation, the content and design of the CMAS and CoAlt assessments will not change in 2025 even if there is a change in our contractor following this procurement effort.

With awareness of the ongoing conversations regarding Colorado's assessment and accountability systems, the released RFP includes flexibilities that will allow the state to pivot and adjust within the new contract as needed based on future legislative expectations and revisions to the Colorado Academic Standards. CDE is committed to working with you to minimize any unintended disruptions that the potential transition to a new vendor may cause. Prospective contractors have until the end of November to submit proposals, and we plan to announce an intent to award a contract prior to the end of the school year.

RFP Review Committee Nominations

Submitted vendor proposals will be evaluated by a committee of Colorado school district representatives and CDE staff with experience in the development, administration, scoring and reporting of large-scale assessments. We are seeking your help in identifying the district representatives who will participate on the committee that will make recommendations for the final contract award. Please consider nominating qualified candidates to be considered as evaluation committee members. Fill out the attached *Participant Interest Survey* if you would like to nominate a qualified candidate, including yourself, for committee participation. Nominations for qualified candidates should be sent to CDE's Assessment Division at assessment@cde.state.co.us by Wednesday, Nov. 8. The Assessment Division will connect with the nominees if they are selected, or to get additional information as needed.





Several meetings (see Participant Interest Survey) will be scheduled for committee members, including a technology system demonstration by prospective vendors. Committee members must be able and willing to spend significant time outside of these meeting dates working independently to read and evaluate the vendor proposals. All committee members must be willing to sign a non-disclosure agreement and commit to attend **all** meetings. While the level of effort is relatively high for committee members, we are hoping to find field representation in each of the areas identified below:

- District and School Administrators (e.g., superintendents, principals)
- Assessment administration experts (e.g., district assessment coordinators)
- Content experts familiar with the Colorado Academic Standards and preferably the process of developing items for statewide assessment. Individuals with experience in item writing, content and bias/sensitivity review, rangefinding, and data review are especially needed.
- Technology experts (e.g., district technology coordinators) familiar with either/both network and device set-up for online testing, and/or the use of student and test management software and test administration software (e.g., KITE Educator Portal, WIDA AMS).
- Individuals with expertise in teaching or directly supporting the instruction of students with disabilities
- Individuals experienced in teaching or directly supporting the instruction of multilingual learners
 - Individuals with expertise in Spanish literacy and the Colorado Academic Standards are also needed
- Individuals experienced in teaching or directly supporting the instruction of students with disabilities
- Individuals with psychometric expertise

Thank you in advance for your assistance with this important procurement effort. District representation and participation is critically important to the integrity of Colorado's state assessment program, including the vendor selection process.
