

(1) Jeffco Education Center

1829 Denver West Drive, Building 27, Golden, CO (303) 982-6500

I-70 to Denver West Boulevard (Exit 263), turn north onto Denver West Marriott Blvd/Denver West Blvd, turn west onto Denver West Pkwy – past the Marriott. Turn left at first stop sign, there are two office buildings on the right. Building 27 is the one nearest I-70; the main entrance is on the south side of the building. The Board Room is on the 5th floor.

(2) NEW Steamboat Springs School District

325 7th Street, Steamboat Springs, CO (970) 871-3199

From the South on Highway 131 or Highway 40: travel north onto US-40, turn right on 7th street, the district will be 5 blocks on the left side.

From the West on Highway 40: turn left on 7th street, the district will be 5 blocks on the left side.

(3) Centennial BOCES

2022 Clubhouse Drive, Greeley CO (970) 352-7404 - The BOCES building is the second building located on the left-hand side of the street (east), a bi-level, red brick building just past Union Colony Prep School. There are signs to direct you. Turn left into the parking lot. The east side is the main entrance.

From the West on Highway 34 Bypass:

Turn left (north) on 65th Avenue (becomes 59th Avenue). Travel to 20th Street. Turn right (east) on 20th Street to Clubhouse Drive (on the hill, under the big, white water tower). Turn right on Clubhouse Drive.

From the East on Highway 34 Bypass:

Turn right (north) on 47th Avenue. Travel to 20th Street. Turn left on 20th Street to Clubhouse Drive, (on the hill, under the big, white water tower). Turn left on Clubhouse Drive.

(4) NEW Northeast Colorado BOCES

From the North on CO-50, travel south turning right on E Wilson St, turn right onto N Logan Ave followed by a left on W Powell St.

From the South on CO-50, travel north turning left on E Wilson St, turn right onto N Logan Ave followed by a left on W Powell St.

From the West on US-6, travel east turning left on S Colorado Ave followed by a left on W Powell St.

From the East on US-6, travel west turning right on S Colorado Ave followed by a left on W Powell St.

FROM HWY 6&50 (aka BUSINESS LOOP 70): On west side of Grand Junction, turn north on 25 Rd. Turn left (east) on Blichman Ave. Western Colorado Community College is on the NE corner of 25 Rd. and Blichman Ave. Meeting will be held in Room B1.

(6) **NEW** East Central BOCES

From East Hwy I-70: Take Exit 361 and turn left on Main Street, then left on D Ave followed by a right turn onto 2nd street. The BOCES office will be on the right side of the street.

From West Hwy I-70: Take Exit 359 and turn right onto US-24 followed by a left on Main Street, then right on D Ave followed by a right turn onto 2nd street. The BOCES office will be on the right side of the street.

From South US-24: turn right onto Main Street, then right on D Ave followed by a right turn onto 2nd street. The BOCES office will be on the right side of the street.

(7) Pikes Peak BOCES

Pikes Peak BOCES is located on the southeast corner of I-25 and Circle Drive in the old Gorman Middle School Building. This is located on the south side of Colorado Springs.

Please Note: The BOCES offices and conference rooms are accessed from the back of this building. The entrance is on the southwest corner of the building. Please DO NOT enter at the front door which is the School entrance. Drive to the back of the building and look for the PP BOCES signage next to our entrance door.

From West Hwy.160: Head east on Hwy. 160, Hwy 160 becomes a one-way and turns into 6th Street Continue on 6th Street. Turn right on State Ave (3rd stoplight) Drive appox. 1.5 miles, turn right onto Lava Ln. Take the 1st right onto Enterprise Dr

The BOCES is located in the Tierra Del Sol Industrial Park between a large red metal building (Layton's Towing) and Coca-Cola.

(10) Swink School District

Swink is located on Highway 50 between Rocky Ford and La Junta.

When you get to Swink, turn south at the Tank and Tummy convenience store.
