**In an effort to maintain student privacy, the Colorado Department of Education made the decision to modify the state and federal grant reports and allocation documents that are posted to the CDE website. This is in response to Family Educational Rights and Privacy Act (FERPA) §99.3 which states that protected information can include "Other information that, alone or in combination, is linked or linkable to a specific student that would allow a reasonable person in the school community, who does not have personal knowledge of the relevant circumstances, to identify the student with reasonable certainty."
