Executive Summary

This report was prepared in accordance with §22-30.7-103(3)(n), C.R.S., which specifies that CDE reports annually about the number of students who withdraw from Colorado K-12 online schools after the pupil enrollment count date (also known as October count). The statute requires that the report include the dates on which students withdrew from enrollment in a Colorado online school, the grade level at which the students were enrolled at the beginning of the school year, the grade levels at which the students were enrolled when the students transferred, and information on whether the students enrolled in another public or private school or home-based education (home school) setting or graduated or completed high school within the same year.

This report presents data and descriptive information from the 2022-23 school year.¹ In this report, student records for withdrawals, transfers, and entries in online schools are analyzed. This report will present information and analysis in the following areas:

Highlights and Notable Trends

- During the 2022-2023 school year, 5,014 students were coded as withdrawing from online schools after the October Count, accounting for 16.9% of the total online school student records analyzed in this report. This is a decrease from the 19.5% of student records coded as withdrawing from online schools in the 2021-2022 school year.
- The two most common reasons for withdrawals in the 2022-23 school year were discontinued education (n=1,505) and transfer to a school in another Colorado school district (n=1,198).
- Student graduations and completions from online schools totaled 24,639 for the 2022-2023 school year, accounting for 83.1% of the student records analyzed in this report. This is an increase from the previous school year when 80.5% of the student records were coded as graduating and completing.
- Online student withdrawals were highest in January (n=1,111 students) and May/June (n=758), aligning with the end of the first semester and the end of the academic year.
- Multi-district online schools reported a withdrawal percentage of 16.8 in the 2022-23 school year, a 2.9% decrease from the 19.7% reported as withdrawing from multi-district online schools in the previous school year. Single district online schools reported 15.9 percent of students withdrew during the 2022-23 school year, a 1.8% decrease from the 2021-22 school year in which 17.7% of students were reported as withdrawing.
- Online schools saw a decline in student withdrawal percentages in the 2022–23 school year compared to 2020–21. Of the schools with sufficient data, 27 reported a decrease in withdrawals, while only one experienced an increase from the previous year.
- Most student withdrawals from online schools occur at the high school level (grades 9–12). In the 2022–2023 school year, 66.4% of all online school withdrawals were from high school students, with grade 12 alone accounting for 1,531 withdrawals—30.4% of the total student withdrawals.

- New enrollments in online schools nearly offset student withdrawals, resulting in a net enrollment decline of just 0.2% from the Student October Count to the End-of-Year data collection. In contrast, non-online schools experienced a larger net enrollment decrease of 5.1% over the same period.

Introduction

Purpose

This report was created in accordance with §22-30.7-103, C.R.S, which requires the Colorado Department of Education’s Office of Online and Blended Learning to produce an annual report on the number of students who withdraw from Colorado K-12 online schools after the pupil enrollment count date.

This report includes dates on which students withdrew from enrollment in a Colorado online school, the grade level at which the students were enrolled at the beginning of the school year, the grade levels at which the students were enrolled when the students transferred, and information on whether the students enrolled in another public or private school or home-based education (home school) setting or graduated or completed high school within the same year. This report includes information and data for the 2022-23 school year.

Methodology

The analyses in this report provide information about enrollments and withdrawals for online schools in Colorado, in alignment with the requirements of the statute. All data utilized for quantitative analyses are gathered from data maintained by CDE. The report relies primarily on the following data collections, as described below:

The Student October Count (October Count) snapshot data collection captures annual student enrollment data and is used as a method for distributing school finances across the state. The October Count data collection is based on a one-day membership count in which school districts and other Local Education Agencies (LEAs), such as a Board of Cooperative Education Services (BOCES) or the state Charter School Institute (CSI), report all students who are actively enrolled and attending classes on the pupil enrollment count date. The pupil enrollment count date is October 1 of each year, unless that date falls on a Saturday, Sunday or major religious holiday. If the pupil enrollment count date falls on a Saturday, Sunday or major religious holiday, the pupil enrollment count date will be the following weekday. While the submission should only include those students who meet the membership and scheduling requirements as of the pupil enrollment count day, the actual submission process begins in September and closes mid-November. The Student October count data collection includes data on pupil enrollment by district, school and grade. Data from the October Count snapshot data collection serves as the statistical foundation for this report.

The Student End of Year Snapshot collects student enrollment updates throughout the school year. Information collected in the Student End of Year snapshot includes entry and exit data for students within the given school year, which is used to track student mobility. The data collected from the Student End of Year data collection is certified in the subsequent school year. Because the collection is certified during the subsequent school year, the data analyzed in this report is from the 2022-23 school year, which was certified in fall of 2023 and finalized in early 2024.



It is important to note that the number of student records may have slight variations based on discrepancies between the Student October Count data collection and the Student End of Year data collection.

Online School Background

In the 2022-23 school year, there were 64 online schools operating in Colorado serving grades K-12. Of the 64 online schools, 44 were multi-district online schools (MDOL). A multi-district online school can enroll students from across the state who reside outside of the district that authorizes the school. The remaining 20 schools were single district online schools (SDOL). Pursuant to statute, MDOLs in Colorado can be authorized by an individual school district, a Board of Cooperative Educational Services (BOCES), a group of school districts, or the state Charter School Institute (CSI). In the 2022- 23 school year, 23 school districts and two BOCES authorized the 44 MDOLs. The 20 SDOLs were authorized by 15 separate school districts.

In the 2022-23 school year, the total student enrollment count for online schools and programs was 30,799. Statewide, the percentage of students enrolled in online schools and programs represents 3.6% of all Colorado public school students. This report does not include data on students enrolled in online programs², and only looks at data for students enrolled in multi-district and single-district online schools. The total student enrollment for online schools was 30,096 for the 2022-23 school year.

As mentioned in the methodology section above, it is important to note that the number of student records (29,653) analyzed for this report will differ slightly from student enrollment totals for students in online schools (30,096) from October count for the 2021-22 school year, as this report uses student enrollment data from the End of Year data collection, which includes enrollment throughout the entire school year.

Table 1 below details for each authorizer, the number of online schools it authorizes, total student enrollment for the district or BOCES, and the number and percentage of students enrolled in online schools within that district or BOCES as of the October pupil enrollment count date.

Student Exit Code

Student Exit Codes and Groupings

When a student leaves a school for any reason, the state collects information from schools and local education agencies through an ongoing process known as the “Student Interchange.” The data from [Student Interchange](#) is then formally archived for the year through the Student End of Year snapshot data collection mentioned in the methodology section of this report. When a student leaves a school, the school is responsible for reporting both an exit date and the reason why the student withdrew from the school (i.e., an “exit type”).

To classify post-withdrawal outcomes for students in alignment with requirements of the statute, exit codes for students who left an online school during the 2022-23 school year have been grouped together as shown in Table 3 below. These groupings are specific to this report and are intended to provide a clear and structured analysis of student withdrawals from online schools and the post-withdrawal outcome for those students. Exit codes classified as withdrawals have been grouped into the following Exit Grouping categories:

In addition to collecting information about whether and why a student withdraws from a school, the Student End of Year Data Collection also collects information about whether a student continues to be enrolled in a school or completes school. Codes that are assigned to students when they continue or complete their education have been classified as “Continued” or “Graduated/Completed” as shown below.

Year to Year Comparison of Student Withdrawals, Continuations, and Completions

In the 2022-2023 school year, students coded as withdrawing from online schools after the October Count totaled 5,014, or 16.9% of the total number of online student records reviewed for this purpose. This is a decrease from the 19.5% of students coded as withdrawing from online schools after the October Count in the prior year.³ Students who were coded as continuing or completing their education in the 2022-23 school year comprised 83.1% of online students whose data were reviewed for this purpose, an increase from the 80.5% of online students who were coded as continued or completed in the prior year.

Despite the increase in the number of students coded as completing and continuing in the 2020-21 school year, the proportion of online students who withdrew or continued/completed has remained relatively stable over time.

Table 4 below shows the total number of students who have withdrawn or completed/continued their enrollment in online schools after the October Count date since the 2017-18 school year, the first year these data were reported.

Statewide Student Withdrawals

Discontinued Education was the most common Exit Grouping for student withdrawals from online schools statewide. This category includes students who were coded as “reached the maximum age (21)” (exit code 01), “pre-transferred to an unknown setting (K-6)” (exit code 06), and “dropped out (7-12)” (exit code 40). In previous reports, these data for the above exit codes were reported separately. In the 2022-23 school year, with the new classification groupings, these data are combined and reported as such.

In the 2023-22 school year, 1,505 students or 5.1% of online students whose data were reviewed for this report were classified under “discontinued education.” In the 2021-22 school year, 1,351 students were coded with “dropped out (7-12),” 306 students were coded as “transferred to an unknown setting (K-6),” and the n count was less than 16 for students coded as “reached the maximum age (21)”. In total, students included in the Discontinued Education grouping in the 2022-23 school year represent a slight decrease from the previous year.

The second most common Exit Grouping for students coded as withdrawing from online schools in the 2022-23 school year was “transferring to a school in another Colorado school district.” Out of the 5,014 students who withdrew from online schools, 1,198 students transferred to a school in a different district within the state. Enrollment data shows that the majority of online students are enrolled in multi-district online schools, which can enroll students from outside of the geographic district that authorizes the school. Consequently, when a student enrolled in a multi-district online school transfers to a school within their home district, it is recorded as a transfer to another district even if the student remains within the geographical bounds of their home district. This unique characteristic of multi-district online schools may help explain the high number of online students transferring to another Colorado school district.

Table 5 below contains information about the statewide withdrawals for online students by exit code grouping for the 2022-23 school year from highest to lowest

Statewide Student Continuations and Completions

Of the students classified in the Completed/Continued grouping, “continued enrollment (exit code 00)” had the most student records for online students during the 2022-23 school year. A total of 20,377 students, or 68.7% of all online school students whose data were reviewed, were coded as having continued at the same online school where they were enrolled on the October Count date. This is similar to the previous school year (2021-22), where 20,744 students, or 67.6% of all online students were coded as continuing in the same online school.

Students coded as graduating or completing were the second most common outcome for online students in the 2022-23 school year. In total, 4,262 students (14.4% of all online students) graduated or completed their education, a slight increase from the 3,760 students (12.3% of all online students) in the 2021-22 school year.

Table 6 below contains information about the statewide continuations and completions for online students by exit code grouping for the 2022-23 school year.

Withdrawal Trends

Timing of Withdrawals

When a student leaves an online school in Colorado, the state collects data that identifies the end date of enrollment at the school. Table 8 below shows the frequency and timing of student withdrawals from online schools after the October Count date during the 2022-23 school year, separated by the month during which the exit occurred. Note that May and June are grouped together according to requirements in State Board of Education rules ⁵ which define the end of the school year to be May and June for the purposes of the end of school year data collections.

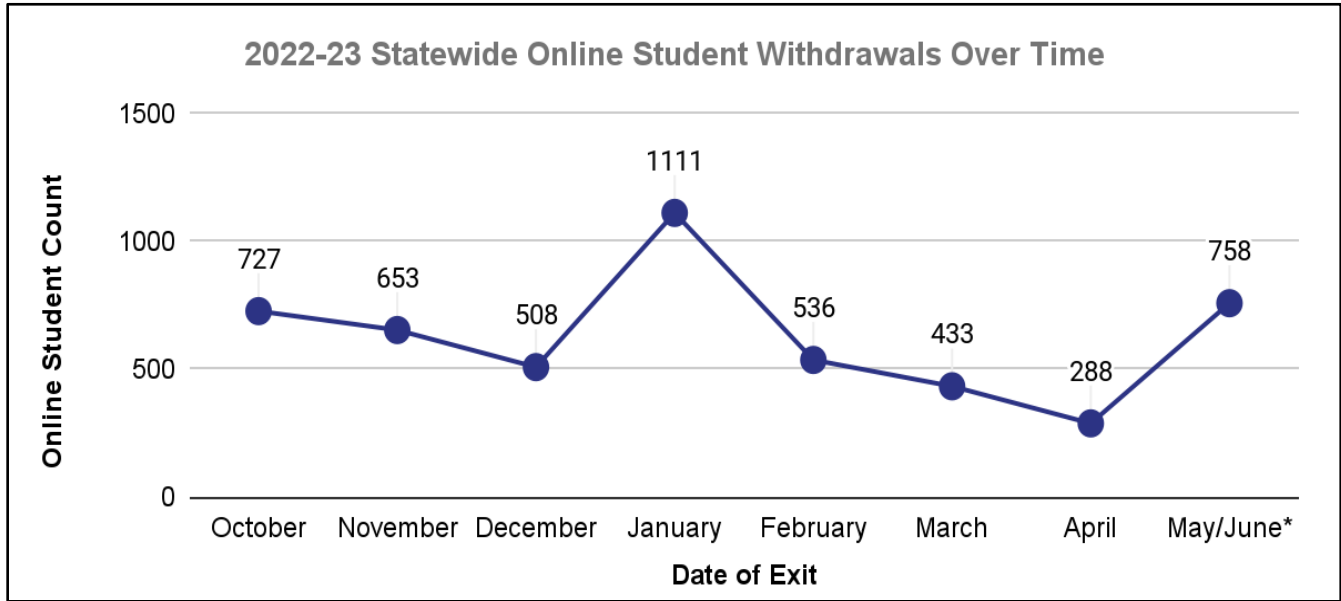

During the 2022-23 school year, student withdrawals occurred at a higher frequency in October and November with a decrease in December and reached the highest point in January at 3.7%. Student withdrawals remained relatively consistent in the months of February through April, and an increase occurred during the combined period of May and June at 2.6%. The timing of these increases in withdrawals coincide with significant points in the academic calendar, such as at the end of the first semester in January and the end of the academic year in May/June.

When considered by semester, withdrawal rates are higher in the spring, with 3,126 withdrawals from January to June, compared to 1,888 withdrawals from October to December. Table 9 below shows the timing of withdrawals based on exit code groupings. Several groupings had n counts too small to report in some months and the withdrawal count is noted as n/a.

During the 2022-23 school year, withdrawal patterns from online schools exhibited notable variability by month and exit reason. The most frequent withdrawal reason in 2022-23 was “Discontinued Education,” accounting for 1,505 online students. The highest incidences of withdrawal for this reason occurred in January (n=229) and May/June (n=228). Transfers to another Colorado district also reached its highest point in January (n=366). In-district transfers and out-of-state transfers had moderate increases in January as well (n=277 and n=106 respectively). Transfers to non-public schools were notably higher in May/June (n=445). Similar to withdrawal patterns for online schools overall, these spikes in withdrawals coincide with the start of the spring semester and the end of the academic year.

Withdrawals by Online School Type

In the 2022-23 school year, multi-district online schools reported 4,425 withdrawals or 16.8% of the online student records reviewed. Multi-District online charter schools reported 2,666 withdrawals (19.4% of student records reviewed). Multi-District online Alternative Education Campuses (AECs) reported 19.5% or 1,615 withdrawals.

Single district online schools reported had a slightly lower amounts of withdrawals with an n count of 584 or 15.9% of withdrawals reported. Single district online AECs reported 22.8% of student withdrawals (n=200). There were no single district online charter schools in Colorado during the 2022-2023 school year and data for this school type is noted as “n/a.” Table 10 below shows the student count of each online school type based on the groupings of “continued or completed” and “withdrew” in the 2022-2023 school year.

Withdrawals by School

In the 2022-2023 school year, the schools with the lowest reported withdrawal percentages were TCA College Pathways (Academy 20) and PSD Global Academy (Poudre R-1). Both online schools had a withdrawal percentage of 7% or less in the 2022-2023 school year. The schools with the highest withdrawal percentage were Colorado Online High School (Byers 32J) at 50.9% and Colorado Online Middle School (Byers 32J) at 83.2%. Seventeen online schools had n counts too small to report and the withdrawal percentage is noted as n/a. Table



10 shows the student count of each online school based on the groupings of “continued/completed” and “withdrew” in the 2022-2023 school year.

In the 2022-23 school year, online schools experienced a reduction in students reported as withdrawing in 2022-23. Among the schools with sufficient data for review, 27 schools reported a decrease in withdrawal percentages from the previous school year. Eleven online schools showed an increase in withdrawal percentages. Table 11



below presents the withdrawal percentages for online schools from 2021 to 2023, including the percentage point difference from the 2021-22 school year to the 2022-2023 school year.

Withdrawals by Grade Level

During the 2022-2023 school year, a significant number of student withdrawals occurred at the high school level (grades 9-12) compared to the elementary (K-5) and middle school (6-8) levels. High school grades accounted for 66.4% of all online student withdrawals, with grade 12 representing 30.4% of the total student withdrawals for all online students. Table 12 below shows the number of students coded as having continued/completed or withdrawn in each grade level during the 2022-2023 school year.

Figure 2: 2022-23 Online Student Withdrawals by Grade Level

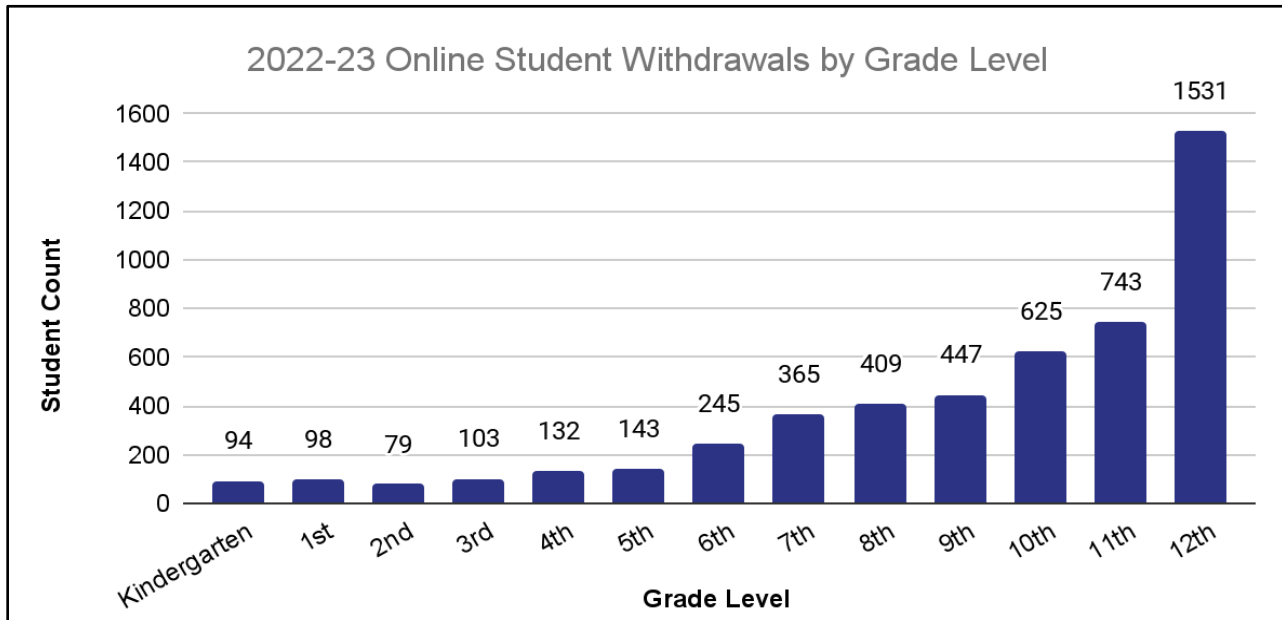


Table 13 below shows the student count for exits in grades 6-12 based on exit groupings for the 2022-23 School year. In grades 6-11, the highest number of students were coded under the grouping "continued." In 12th grade, the majority of students were categorized under "graduated/completed education" with 4,015 students, making up 52.6% of the 12th-grade cohort. The second largest group in 12th grade were those who "continued," with 2,092 students, making up 27.4 percent of 12th grade online students. The third highest grouping of students in 12th grade was "discontinued education," which included 1,013 students, making up 13.3% of 12th grade online students.

Ending Grade Level Student Transfers

Statute requires the grade level in which a student was enrolled at the time of transfer from an online school to be reported. In previous reports, this information was derived from an analysis of student retention codes. However, following further review, it was determined that a more accurate reflection of statutory intent would be achieved by analyzing students who were reported in the Student October Count as enrolled in an online



school, subsequently transferred to another Colorado public school, and were then reported as enrolled in a different grade level at the new school.

Table 14 below shows the total number of online students who transferred to another public school within Colorado after the October count date over the last five school years. Among these students, the table identifies those whose grade level reported at the time of transfer differed from the grade level reported during October count. Additionally, the table disaggregates grade level changes based on whether the student transferred within the same school district or to a school within a different Local Education Agency (LEA), such as another school district or Board of Cooperative Educational Services (BOCES).

It is important to note that recorded grade changes include both upward and downward grade level changes occurring within the same academic year. This analysis is limited to student transfers within Colorado public schools. Data on grade level changes are not available for students who transferred to home-based education, non-public schools, or schools outside of Colorado.

In 2022-23, 240 grade changes were recorded among 2,040 student transfers, indicating that 11.8% of students who transferred to another Colorado public school were enrolled in a different grade level upon transfer than the grade level they were enrolled in at October Count.

New Enrollment

Statewide Enrollment After October Count

In addition to students exiting online schools, students also enroll in online schools throughout the school year. Table 15 below shows the state level enrollment for online and non-online schools at the Student October Count data collection and at the Student End of Year data collection. The pupil count for online schools from the Student End of Year data collection was only 1.5% lower than the pupil count for online schools from the Student October Count data collection. By comparison, the final enrollment for non-online schools was 5.3% lower than the pupil enrollment from the Student October count.

As shown in Table 15 below, the net enrollment of online schools remained relatively stable throughout the 2022-23 school year.

New Enrollment and Withdrawals from Online Schools After October Count

Table 16 displays the number of students who entered each online school after October 1st. Due to student privacy restrictions, the difference shown between withdrawals and enrollments in schools with small n counts will be shown as “n/a” in Table 15.

Of the online schools with n counts high enough to report, the majority had more new students enroll2 than students who withdrew after the October 1st enrollment count. Of note, 30 online schools enrolled a higher number of students than the number of students who withdrew in the 2022-23 school year.

Conclusion

The 2022–2023 school year marked continued stabilization in Colorado’s online school enrollment trends. A total of 5,014 students withdrew from online schools after the October Count, representing 16.9% of the student records analyzed, a notable decrease from 19.5% in the previous year. Graduation and completion outcomes accounted for 83.1% of student records, which is an increase from the previous school year (80.5%).

Withdrawals were most common in January and at the end of the school year, with high school students (grades 9–12) comprising the majority of students who exited. Grade 12 alone represented over 30% of all online withdrawals. The primary reasons cited for leaving were discontinued education and transfers to schools in other Colorado districts.

Both multi-district and single-district online schools reported lower withdrawal percentages compared to the previous year. Among schools with sufficient data, 27 reported a decline in student withdrawals, while only 1 showed an increase. New enrollments closely balanced out withdrawals, resulting in a minimal net enrollment decline of just 1.5%.

These trends suggest that online schools are retaining students at improved rates, particularly at the high school level, while continuing to provide viable educational pathways for graduation and completion.
