### Why do we Monitor Compliance Indicators

- Consistent with OSEP Memo 09-02, CDE must describe the specific actions that were taken to verify the correction.
- OSEP requires States to report how we corrected non-compliance.
- Because Colorado was less than 100% compliance, the state must report on the status of correction of non-compliance.
- The CDE must review updated data to determine if the AU is correctly implementing the specific regulatory requirements related to Indicator 11.



### Indicator 11

- Child Find-percent of children evaluated within 60 days from receipt of consent to evaluate
- Indicator 11 data is collected via the end of year (EOY) data submission
- 32 AUs were found to be out of compliance as per the 17-18 data submitted.



### Indicator 11: How will CDE Monitor for Compliance

- For AUs not meeting 100% compliance, the CDE will send a formal letter indicating the process the AU needs to follow in demonstrate correction of noncompliance.
- An **Indicator 11 Delay Correction Tracker** will be uploaded to the DMS under the Compliance Tab which will notify the AU of IEPs that were out of compliance for the 60 day timeline.
- Once the Indicator 11 Delay Correction Tracker has been completed, the AU will upload the completed tracker to the DMS/Compliance Tab/Attachments by December 15<sup>th</sup>, 2019.
- CDE will review the SY 18-19 EOY data submissions by the AU to verify that the AU is correctly implementing the **specific** regulatory requirements related to Indicator 11.

### Indicator 12

- Part C to B Transition-percent of children found Part B eligible with IEP implemented by 3<sup>rd</sup> birthday.
- Indicator 12 data is collected via the end of year (EOY) data submission
- 12 AUs were found to be out of compliance as per the 17-18 data submitted.



#### Indicator 12: How will CDE Monitor for Compliance

- For AUs not meeting 100% compliance, the CDE will send a formal letter indicating the process the AU needs to follow in demonstrate correction of noncompliance.
- An Indicator 12 Correction Tracker will be uploaded to the DMS under the Compliance Tab which will notify the AU of IEPs that were out of compliance for the Part C to B transition.
- Once the Indicator 12 Correction Tracker is completed, the AU will upload the tracker to the DMS/Compliance Tab/Attachments by November 1<sup>st</sup>, 2019.
- CDE will review the SY 18-19 EOY data submissions by the AU to verify that the AU is correctly implementing the **specific** regulatory requirements related to Indicator 12.
