Meeting Activities

Reminder of work and purpose

- The facilitator reminded the DWG of the standards of quality and before, during, and after meeting norms.
- CDE addressed the question the DWG had from the November meeting
 - Role of DWG in READ interim assessment review
 - Making specific recommendations to the department as identified in H.B. 19-1134. WEST Ed is taking recommendations into the review process.
 - Role of DWG in Kindergarten School Readiness (KSR) work and more information on KSR plans
 - Role is not direct and not spelled out in statute. CDE wanted the DWG to understand the work and the connections CDE is making for kindergarten school readiness.

The DWG will re-form an Assessment Protocol Small Working Group. Melissa Colman recommended Anji Gallanos and Floyd Cobb attend the Small Working Group meeting before West Ed joins the DWG on February 25, 2022.

The facilitator, Debbie Hunsaker reviewed all assessment protocol resources and asked the DWG to form a new Assessment Protocol Small Working Group. The group will begin meeting in February 2022 to review and cohesively organize all documents.

University of Oregon - Dyslexia Pilot Project

- Nancy Nelson shared the dyslexia manual and gave an overview of the document.
- Nancy Nelson discussed the Dyslexia Pilot Project at a Glance,
- Nancy Nelson reviewed the assessments they are using with the pilot schools.
- Carol Dissen, Marissa Pilger Suhr, and Nancy Nelson discussed the three schools that volunteered to apply for the pilot.
- Nancy Nelson discussed what year 2 or 3 might look like for students that are identified for intervention early and how ideally students wouldn't need additional support. However, an important part of protocol is providing a space for students that might not need special education to still get access to intervention.
- Melissa Colman discussed the matched comparison schools. CDE is still in the process of gaining approval to work with the schools that have been identified.
