Longfellow Elementary hosts a k-3 Summer school program targeting reading intervention for students identified with an SRD. Our Summer School teacher uses Amplify-mCLASS Reading Edition kindergarten and First Grade All Components to target student gaps and offer explicit instruction to fill in those gaps. Students are identified and prioritized based upon scoring through DIBELS testing. Our
intervention materials used are Amplify-mCLASS Reading Edition, the Haggerty Phonemic, Orton Gillingham-Yoshimoto Phonological & Phonemic Awareness, and Phonics & Word Study Awareness
Curriculum. At the end of the Summer school program our interventionist again uses DIBELS testing to assess students' growth. Our desired outcomes are that our students would then be within the expected reading comprehension for their grade level.
