Approximately 70 students in Rocky Ford were identified as having significant reading deficiencies. These students are in need of extra instructional support to address the gaps in their learning. To support students with significant reading deficiencies, the district will provide intervention services during the school day. The intervention teacher providing the support will use materials from the core resource, Wonders - McGraw Hill, and also Orton Gillingham resources will be used for specific interventions. The goal is to help at least 30 of these students to improve their reading proficiency enough to earn their way off of the READ plans.
