The reading interventionist works in collaboration with classroom teachers to implement reading interventions using SIPPs and Haggerty materials. The goal of this individual is to reduce the number of students identified with significant reading deficiencies. Current data indicates that we have approximately 25% of students who are identified with a reading deficiency. This data comes from BOY, MOY, and EOY data taken from Dibels assessments. Students identified with a significant reading deficiency receive bi-weekly progress monitoring to support the reading interventionist with planning and implementing lessons.
