We will offer Summer Literacy Camp for all students K-3, identified as SRD, on an active READ Plan, or who met the SRD status at any of the benchmark periods during the year. Staff has been trained throughout the year by 95% Group. We will be using 95% Group's Summer Booster program. Funds will be used to pay salaries and benefits for staff, training for Summer Booster, and materials for the program. Our expected outcome is to increase or at least maintain students' Acadience scores from the end of the school year through the end of the Summer Literacy Program. We will continue to use Acadience to progress monitor students during the Summer Literacy Program. We also aim to decrease the "summer slide" between end of the year and beginning of the year scores in the 2023-2024 school year.
