The District utilizes iReady assessments to identify students whose reading and literacy scores are below grade level. K-2nd grade students who are identified as having a significant reading deficiency or who score below grade level in reading are invited to join the Afterschool Tutoring Program that meets for one hour twice per week on Monday and Thursday throughout the school year. Students are placed in small groups based on data and are supported with the Orton Gillingham reading through the IMSE Intervention program. The tutors include grade level teachers and literacy interventionists who already serve this group of students during the school day and are well-versed in the science of reading. These extra hours, two days a week for one hour each for two teachers, are compensated at \$40/hour plus benefits which run 23.3% (for Pera, Medicare, unemployment and workers compensation). The desired outcome is to bring these students closer to or up to grade level.
