Our READ Act data shows that our students could benefit from more strategic, targeted, and individualized lessons particularly in the areas of vocabulary and comprehension. Our plan to purchase and utilize Curriculum Associate's iReady reading program will directly impact our students' growth and achievement in these areas. We expect that the diagnostic data and consistent weekly use of lessons, in addition to CDE approved teacher-led intervention lessons, will provide our students on READ plans with the skills necessary to meet grade level proficiencies. Our students will meet their individualized stretch growth goals closing the gap of their reading deficits. The adaptive nature of iReady will allow students to begin working at their own level providing targeted instruction to every student's strengths and areas of growth. The real-time data provides opportunities for teachers to monitor student learning and progress toward proficiency. We expect that with the help of the iReady lessons we will be able to move 15% of our READ plan students off of their plan next year.
