By encouraging parents and caregivers to participate actively in their children's reading journey, these initiatives foster a nurturing and supportive environment that reinforces classroom learning. Access to High-Quality Reading Materials: Another critical aspect of the planned expenditure is to ensure access to diverse and high-quality reading materials in schools. By updating and diversifying classroom libraries and providing age-appropriate, culturally relevant reading materials, students will be more motivated to read and explore various topics. Expected Outcomes and Goals: Improved Reading Proficiency: With the implementation of the READ Act, it is anticipated that student reading proficiency will improve significantly.
