

Special Education End-of-Year Collection Summary



This collection is required to obtain data on students who were referred, evaluated, and/or received Part B Special Education services in an Administrative Unit or State Operated Program throughout the school year. The reporting period for this collection is **July 1, 2022 through June 30, 2023**.

Data Uses

- EdFacts - data submitted to the US Department of Education as required by 34 CFR §300.618
 - Large focus on students ages 14-21 exiting from Special Education
- State Performance Plan APR Indicators 1, 2, 11, and 12:
 - Indicator 1: % of youth with IEPs graduating with regular diploma
 - Indicator 2: Dropout – % of youth w/ IEPs dropping out
 - Indicator 11: Child Find - % of children evaluated for Part B within 60 days
 - Indicator 12: Part C to B Transition - % of children found Part B eligible with IEP implemented by third birthday

Path 2 - Part B Services (ages 2.5 to not yet 4)

- What is it?
 - Part B of IDEA governs how special education and related services are provided to school-aged children with disabilities
 - Path 2 includes children ages 2.5 but not yet 4, who were referred from Part C to Part B services
 - These students are being referred/evaluated for an IEP (individualized education plan)
- Who to Report?
 - All children receiving Part C Services that were referred to Part B services
 - This includes those referred to Part B (even if they weren't evaluated), those evaluated for Part B, those evaluated and found not eligible for Part B, as well as those who actually had an IEP implemented and received Part B Services during the reporting period
- When to Report?



- For those determined eligible, report in the school year in which the IEP was implemented
- If IEP was scheduled to be implemented this year but wasn't, report referral and evaluation information from previous reporting period and indicate reason for delay
- For students determined NOT eligible for Part B, report them in the reporting period in which the Initial Eligibility Meeting occurs

Path 3 - Part B Services (ages 2.5 – 21)

- What is it?
 - Part B of IDEA governs how special education and related services are provided to school-aged children with a disability
 - These students are being referred/evaluated for an IEP (individualized education plan)
- Who to Report?
 - Students ages 2.5 – 21 who were referred, evaluated, and/or received special education Part B services and were not receiving Part C services immediately prior
 - This includes those referred to Part B (report ONLY if parental consent to evaluate was received), those evaluated for Part B, those evaluated and found not eligible for Part B, as well as those who actually had an IEP implemented and received Part B services during the reporting period
- When to Report?
 - For those determined eligible, report in the school year in which the IEP was implemented
 - If IEP was scheduled to be implemented this year but wasn't, report referral and evaluation information from previous reporting period and indicate reason for delay
 - For students determined NOT eligible for Part B, report them in the reporting period in which the Initial Eligibility Meeting occurs

Special Education or Part C Referral Field

This is one of the most important fields in the EOY data collection. This field indicates the type of referral(s) that occurred for each student and which path(s) the student's evaluation events should be reported in. Many of the edits are based upon this field, so first and foremost, be sure this field is correct before looking into other edits.

Special Education or Part C Referral – Indicate the type of referral(s) that occurred for each student. One of the most common codes reported in this field is **06 - No Initial Referral During the Current Reporting Period**. This is the code used for students who came into the school year with an IEP, already receiving Special Education services. If a student had an initial evaluation during the reporting period, select one of the other codes as applicable to their path.

01	Part C Evaluation (Path 1 Only) – Use this code for children 0-3 years old who were referred for and/or had a completed Part C evaluation during the reporting period, whether or not they were determined to be eligible.
02	Part C to Part B Transition (Path 2 Only) – Use this code for children 2.5 but not 4 years old (at the time of the referral) who were referred for a Part B Evaluation (from a Part C Agency), whether or not they were determined to be eligible for Part B Services.
03	Part B Services (Path 3 Only) – Use this code for all students who are <u>referred for a Part B Evaluation (NOT from a Part C Agency)</u> , whether or not they were determined to be eligible for Part B Services.
04	Part C Evaluation & Part C to Part B Transition (Paths 1 & 2) – Use this code for children 2.5 but not 4 years (at the time of the referral) who had a Part C evaluation, received Part C Services AND were referred for a Part B Evaluation (from a Part C Agency), whether or not they were determined to be eligible for Part B Services.



05	Part C & Part B Evaluation (Paths 1 & 3) – Use this code for students who had a Part C and a Part B Evaluation on the same day; OR for students who had a Part C Evaluation during the reporting period and were determined not to be eligible for Part C Services and later, in the same reporting period, were referred for a Part B Evaluation.
06	No Initial Referral During Current Reporting Period – Use this code for all students who began receiving services prior to July 1 of the current reporting period.
07	Part C to Part B Transition & Part B Evaluation (Paths 2 & 3) – Use this code for students who received Part C services and were referred for a Part B evaluation (from a Part C Agency), and were either determined not eligible for Part B services or began receiving Part B services that were discontinued AND were later, in the same reporting period, referred for a Part B evaluation.

NOTE: A “00” should be reported in this field for students parentally placed in private school (PPPS=02) that had no referral to Special Education and did not receive Special Education services in the current reporting period. This type of record is reported for December Count purposes only.

Exits from Special Education

An exit for the purposes of this snapshot indicates a student that has exited from Special Education services from your AU. The Basis of Exit field should be populated with the applicable Special Education exit code in this case. The Date of Exit from Special Education must fall within the current reporting year. Students ages 14-21 are included in the EdFacts data.

Basis of Exit – Indicate the circumstances under which the student **exited from Special Education services in your AU**. If student is still receiving Special Education services in your AU, this field must be zero-filled.

Exit Codes – Permanent Withdrawals	
01	Reached Maximum Age for Services – A student who left school because he or she has reached the maximum age to receive an education program allowed by federal, state, or local laws.
02	Death – A student whose membership is terminated because he or she died during or between regular school sessions.
Exit Codes – Outgoing Transfers	
05	Transfer to a school located in a different country – A student who transfers to a public school located in another country. This transfer must be documented by either an education records request from the receiving school, a signed confirmation of enrollment and attendance, or an official confirmation of emigration from a federal agency.
06	PK-6 Student Exited to an Unknown Educational Setting/Status – ONLY applicable to students in grades PK – 6 if the reporting AU does not have information about the educational environment into which a student transferred. If the educational environment to which the student transferred is known, use the appropriate exit code (13 if transferring to another Colorado AU, 14 if transferring to another state, etc.). Note that districts are required to obtain documentation of transfer for students exiting grades PK – 6.
09	Transferred to Regular Education – A student who was served in Special Education at the start of the reporting period, but at some point during that 12-month period, returned to regular education. These are students who no longer have an IEP and are receiving all of their educational services from a regular education program (This code is not intended for students for whom the parent has revoked consent for services; for these students use code 60).
13	Transfer to a Public School in a Different Administrative Unit – A student who transfers to a public school, Special Education program, or Detention Center located in another AU within the state (examples: a Special Education student who transfers to another administrative unit and is known to be continuing in a Special Education program, a student going to a detention center run by another school district). This code should be used for students who transfer to CSDB or CMHI-Pueblo.
14	Transfer to a School Located in a Different State -A student who transfers to a public school located in another state. This transfer must be documented by either an education records request from the receiving school, a signed confirmation of enrollment and attendance.
15	Transfer to a Non-Public School – A student who transfers to receiving an education program at a non-public school.
16	Transfer to Home-Based Education (home schooling) – A student who transfers to receiving an education program in a home-based education environment for reasons other than health.



18	Transfer to a Career and Technical (vocational) Education Program not Administered by a Colorado School District or BOCES – A student who transfers to an occupational training program, recognized but not administered by the school district, that leads to a certificate or other evidence of completion. (e.g., Job Corps)
21	Transfer to a Facility Operated by the Colorado Department of Corrections or Division of Youth Corrections – Student is <u>incarcerated in a correctional facility</u> . NOTE: Students transferring to a detention center not operated by the reporting administrative unit should be coded with a 13 exit code (if the detention center is operated by a district within your administrative unit, this student should not be exited).
Exit Codes – Other Withdrawals	
40	Discontinued Schooling/Dropped Out – A student who was enrolled at the start of the reporting period but was not enrolled at the end of the reporting period and did not exit special education through any of the other exit means. Students who are extremely ill and unable to continue special education services, not even indirect services, must be coded as Discontinued Schooling/ Dropped Out.
50	Expulsion – A student who leaves school involuntarily due to an expulsion approved by appropriate school authorities and is not receiving any education benefits. <u>Students who receive education benefits (such as tutoring) during expulsion are not considered expelled/exited for EOY purposes.</u>
60	Parent Revokes Consent for Services – Subsequent to the initial provision of Special Education and related services, the parent revokes consent.
70	HSED Transfer – Student exits to participate in a HSED preparation program not administered by the district (e.g. a HSED program offered through an institution of higher education or a private company.)
Exit Codes – Graduating or Completing	
90	Graduated with Regular Diploma – A student who received a regular high school diploma upon completion of local requirements for both course work and assessment. Includes students with disabilities who meet all requirements of an IEP aligned with state standards.
92	Completed (non-diploma certificate) – A student who has received a certificate of completion, attendance, or achievement. Also includes students who have not received a high school diploma but have been granted admission to an institution of higher education.
93	High School Equivalency Diploma (HSED) – A student who has received a HSED certificate upon completion of a HSED preparation program <u>administered by the reporting district.</u>
94	Student transferred to a non-district run HSED program AND received a HSED certificate all in the currently reported school year.
