Updates and Information

New Notification Template from County Offices click here

The purpose of this template is for county departments of human services to notify a school, district, and/or CWEL regarding an educational placement change. It is intended to clarify requirements under the Every Student Succeeds Act (ESSA) which gives students in foster care the right to be enrolled immediately in a new school when it is not in the student's best interest to remain in the school of origin. For more information about ESSA see the next section.

According to C.R.S. 22-32-138, the CWEL is responsible for working with county departments of human services, child placement agencies, and CDHS (for the Division of Youth Corrections) to facilitate:

- prompt and appropriate school placements;
- the prompt transfer of academic records, assessments and/or education plans; and
- help students enroll in a new school, when in their best interest.

Every Student Success Act (ESSA) Update on Foster Care click here

This is the very first piece of guidance issued from the Department of Education in collaboration with the U.S. Department of Health and Human Services that addresses the unique needs of students in foster care. This guidance contains 40 frequently asked questions around ESSA and Foster Care. In addition, there is a sample letter that LEA's can use to connect with the "Point of Contact" that will need to be designated at each of the county human service offices across the state.
