#### 1. SB23-219 implementation updates

- Work Group members reviewed and discussed the final draft SDS authorization process and provided input regarding requirements and other aspects of the guidance document; among other point brought up the legislation regarding seclusion - <a href="https://leg.colorado.gov/bills/hb24-1167">https://leg.colorado.gov/bills/hb24-1167</a> - is set to be noted in policies and procedures as applicable

#### 5. HCPF resource guide update - Michele Craig

 The Work Group received an update regarding a draft resource guide being developed by HCPF for facility schools to utilize. Michele collected positive feedback and will bring the next iteration to the Work Groups attention.

### 6. Tuition rate and ECEA rules update

 The Work Group was provided with an update regarding the new tuition rate system and notice of rulemaking by the state board of education at their March 13-14 meeting




