Waiver Update – Pat Chapman

- Originally submitted in March 2015
- State Board of Education (SBE) study session on October 27 to consider and grant permission for amendments
- SBE approved amended waiver at November meeting
- Update on reauthorization discussion in Washington

Accountability Work Group Update – Alyssa Pearson

- Accountability hold for current school year
- Planning for release of frameworks in fall of 2016
- Accountability Work Group is developing new frameworks with input from various groups, including:
  - o Rural LEAs
  - o Assessment Experts
  - o Advocacy Groups
  - o Superintendent Advisory Group
  - o Technical Advisory Panel for longitudinal growth
  - o The Center on Standards and Assessment
- New law will likely give states responsibility for accountability system
- Considering performance measures beyond one state test
- Alyssa provided copies of framework mock-ups
- Committee discussed the idea of an aggregated subgroup
- Consensus in state that growth will remain in frameworks
- 11<sup>th</sup> grade assessment is out for bid

Neglected and Delinquent Programming – Stacy Goodman

- Webinar trainings upcoming
- Annual (October) count is not providing accurate information
  - o Irregular attendance
  - o Schools wait until after October count to refer students
  - No flexibility from USDE
- Issue of some facilities that provide acute psychiatric care are educational programs are not supported by Title I-D

  - o Avoid using Cons App for monitoring and data reporting purposes
- Application to be field tested in late winter / early spring
- Modules available in early April
- Future application may be phased throughout the year
- Committee expressed concern about delayed timeline and release of application for 16-17

Monitoring – Jeff Klein, Brad Bylsma, and Barb Goldsby

- CDE updated committee on plans for combined monitoring of ESEA/IDEA programs
- Committee provided positive feedback for initiative
  - Streamline processes
- Committee asked for adequate preparation time
  - Also noted that many districts are not collaborating on these programs
  - o Messaging will be important when program is rolled out
