- Provide time for group work on one of the charges of the working group- *Analyze the implementation and demonstrated effectiveness in other states of statewide legislation for dyslexia screening, educator training, and other dyslexia-related laws (HB 19-1134 22-20.5-103 (b))*
- Discuss homework for November

Meeting Activities

Welcome

Facilitator, Debbie Hunsaker welcomed all of the Dyslexia Working Group (DWG) members.

Context Setting

Floyd Cobb, Ph.D., Executive Director, Teaching and Learning discussed the norms of observers in the room and provided information on HB 19-1134, DWG's roles and responsibilities, the READ Act, and the Dyslexia Pilot.

Launch Activity

Debbie Hunsaker engaged the DWG in a discussion around their personal reasons for being a part of the DWG and the connections with other DWG members.

Debbie Hunsaker reviewed the processes the DWG will be using to work together as a team, and the DWG discussed the benefits of the processes.

Standards of Quality and Scope of Work

Debbie Hunsaker reviewed sections 22-20.5-103 (2) (a-g) from House Bill 19-1134 (the authorizing statute for the DWG) and discussed the timeline for the DWG, including the October meeting which focused on HB 19-1134 22-20.5-103 (b) *Analyze the implementation and demonstrated effectiveness in other states of statewide legislation for dyslexia screening, educator training, and other dyslexia-related laws*. Future meetings will focus on the following:

- Recommending dyslexia screening tools and processes
- Creating a statewide plan for identifying and supporting students with dyslexia
- Considering educator training in recognizing and providing interventions for students with dyslexia
- Providing recommendations to the department concerning the design and implementation of the pilot program

Subcommittee Work Time

Subcommittees were formed to review and analyze the other states plans DWG members read through in between the September and October meetings. Each DWG used guiding questions sent from Debbie Hunsaker that align with HB 19-1134 22-20.5-103 (b) *Analyze the implementation and demonstrated effectiveness in other states of statewide legislation for dyslexia screening, educator training, and other dyslexia-related laws*.

DWG members will continue reading the recommended state plans in preparation for the December 6, 2019 meeting.
