Considerations for Coding Parent Excusals

Parent excuse codes are used when a parent excuses their child from participating in state content assessments. For accountability purposes, these codes are used to remove records from the accountability participation rate calculation that determines whether a school or district's rating is decreased due to participation. The Assessment Division shared clarifying language about the coding process last week. If you did not already receive the communication, scroll down to the bottom of this email and/or refer to the guidance document. More information about participation requirements and accountability implications, as well as unique considerations for 2024, are available in the 2024 Participation and Accountability Guide.

UIP Template Roll Over April 15: New Streamlined Template Option for 2024-25

District users can still access, edit, and post 2023-24 UIPs, if needed.

For the 2024-25 school year, schools and districts have the option to use the new <u>streamlined Unified Improvement Plan (UIP) Template</u> beginning on April 15. Coding for Parent Excuse from Participating in State Testing

The attached document provides guidance on the application of parent excuse coding for both CMAS and PSAT/SAT. Parent excuse coding was created to indicate which missing assessment scores resulted from non-participation in a state content area assessment because a parent excused their child from testing. This coding complements state statute which requires local education providers to establish a process that allows parents to excuse their child from state content assessment participation.

Since the parent excuse code became available and as recently as last summer, districts have discovered and reported instances of local inadvertent parent excuse miscoding for students who completed testing. In these cases, students, parents, and educators expected to receive results; however, the parent excuse coding processed and prevented the production of scores.

This year's process will include automated checks to ensure that students who participate fully in state content assessments receive a score. These checks will prevent incompatible coding (i.e., parent excuse) for students who had the opportunity to respond in all CMAS units of testing or who engaged with PSAT/SAT testing.

In the rare case that a parent excusal from participation in the state assessment is received while a student is actively testing in the last unit of a CMAS assessment or while a student is actively participating in a PSAT/SAT testing room, the attached guidance includes the steps that will allow the processing of a parent excuse code. The number of records impacted by this update should be extremely limited.

NOTE: Parent excusals should not be solicited, including after absences for non-related issues. If the student is absent for the entire testing window, absent should be coded.
