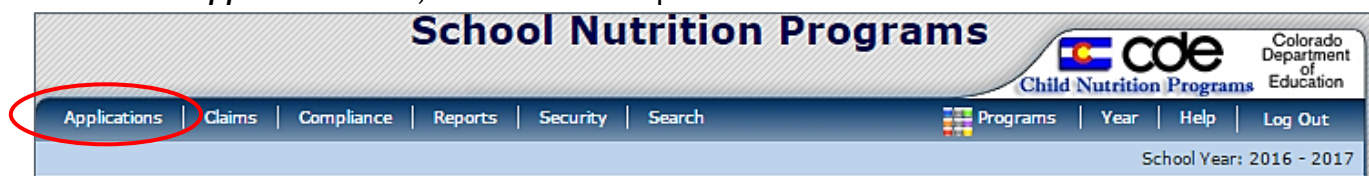

Although all SFA sites will populate, only apply for those eligible to participate in the FFVP.

Sites selected for participation for the FFVP must:

- Be an elementary school.
- Begin FFVP operations at the start of the school year.
- Have a 50 percent, or more, students who are eligible for free or reduced price lunch. Preference will be given to those schools with the highest eligibility percentage.
- To determine school percentage, SFAs must use [2017-2018 PK-12 Free and Reduced Lunch Eligibility by District, and School data](#) located at: <http://www.cde.state.co.us/cdereval/pupilcurrentschool>
- Participate in the NSLP; however, service of the FFVP must fall outside of all other meal service times
- Submit a complete FFVP application

Step 1: FFVP Sponsor Application

- To complete the Sponsor Application, click **Add**
 1. Complete the Contact Information for the FFVP contact
 2. Under **Invited Sites**, select the sites that applying for the FFVP
 3. Click **Save**

Step 2: FFVP Site Application

- To add a FFVP Site Application - Click **Add**, under the 'Action' tab

Section A:

- Verify Contact information (contact information will prepopulate from the SNP applications)

Section B:

- Indicate the grades participating in the FFVP, by checking all boxes that apply

Section C:

- The free and reduced- price data will pre-populate from the current eligibility file, October 1 PK-12 data

Section D:

- Indicate School Principal Contact

Section E:

Complete questions #3-#8

- Question #7- Must reflect the number of eligible students expected to participate in the FFVP
- Question #8-
 - Ensure the FFVP is only served during the school week
 - Enter the number of FFVP service days per week

Section F:

Complete questions #9 -#20.

- Incomplete or inadequate responses will not be accepted
- Use clear, concise sentences

Document Attachments (Optional)

- Attach additional documentation (i.e. support documentation)



Submit for Approval:

- Click **Save** to submit
- Ensure site status is **Submitted**
- Continue this process for each additional site applying for the FFVP
- Notify the CDE OSN of your application submission**

Application Review:

Once the CDE reviews submitted applications, a letter will be sent notifying the SFA of the application status.

Please note, schools **may not** be awarded FFVP funds if the:

- School fails to meet the defined deadline for the submission of a complete FFVP application.
- School does not have the support of its administration.
- CDE has determined noncompliance with the administration of another Child Nutrition Program.
- CDE determines that a school cannot properly operate the FFVP.
