Summary of Reporting Requirements

Food Safety Inspection Requirements and Reporting

Schools participating in the National School Lunch Program and/or School Breakfast Program must obtain and report at least two food safety inspections conducted by a state or local agency responsible for such inspections. *It may not be possible for schools to obtain two food safety inspections per year because of local agency capacity, but they still must be requested each year. How to Report in the [Colorado Nutrition Portal](#)

- The total number of food safety inspections conducted in food preparation and/or service areas in schools under its jurisdiction during the prior school year.
- In the Hub indicate the following:
 - The number of schools that had *zero* health inspections. Include a brief explanation for the reason for not meeting the inspections requirement of at least two inspections.
 - The number of schools that had *one* health inspection. Include a brief explanation for the reason for not meeting the inspections requirement of at least two inspections.
 - The number of schools that had *two* health inspections.
 - The number of schools that had *more than two* health inspections.
- For accuracy, do not report the same schools under more than one category.
