## Legislative Wrap Up

Melissa Bloom, Senior Policy Associate at CDE, along with Brittany Lane from the Department of Higher Education, walked the group through the legislative update. A total of 45 education-related bills passed. 41 of those bills require technical assistance or implementation from CDE. Fourteen of the bills include new requirements for districts. CDE is collaborating with CDHE on four bills related to the educator shortage.

Specific focus areas were on the educator shortage bills in addition to school safety and funding that is available. Other items of note included the bill addressing parent notice for school safety and protection, as well as changes to transportation statutes.
